THE TEN COMMANDMENTS OF EXPERTS (Shamelessly patterned and built from material stolen from NCIDS who, having shamelessly stolen from Paul Herzog, let me get near it.)

- 1. THOU SHALT THINK CRITICALLY ABOUT THE FACTS OF THY CASE BEFORE DECLARING THY EXPERT NEEDS.
- 2. THOU SHALT READ AS MUCH RESEARCH IN EXPERT FIELDS AS NEEDED TO TEACH TO THE UNKNOWING, FOR IT IS WRITTEN: KNOWLEDGE IS THE FOUTAIN FROM WHICH ALL RIGHTEOUS DECISIONS FLOW.

- 5. THOU SHALT THOROUGHLY AND COMPLETELY INVESTIGATE EVERY PROFFERED CHAMPION, INCLUDING THINE OWN, FOR BLESSED ARE THOSE WHO QUESTION THEIR OWN BEFORE DECIMATING OTHERS.
